If you should elect Option 2, it is advised that no funeral arrangements or other personal arrangements be made until you are further notified by this office.

Will you please complete the enclosed form, "Request for Disposition of Remains" and mail in the enclosed self-addressed envelope, which requires no postage, within 30 days after its receipt by you? Its prompt return will avoid unnecessary delays.

Your letter has been referred to this office for information concerning your son, the late Frivate First Class Lawton T. Gay.

the official records of this office show that the remains of your son were interred in the U. S. Military Gemetery, Margraten, Holland, Plot R, Row 7, Grave 156. This cometery is located approximately twelve miles northwest of Aschen, Germany and eight miles southeast of Maastricht, Holland.

There are no provisions whereby the War Department can furnish photographs of individual graves deceased military personnel or of military owneteries outside the United States, therefore, it is not possible to comply with your request.

Now that Japan has been defeated immediate plans are being formulated with a view to returning to the next of kin the remains of their loved ones. This sacred duty will be carried out by the Government at its expense and insofar as practicable in accordance with the expressed wishes of the legal next of kin, who will be notified by this office well in advance of the actual return of the remains. The mission as a whole is world wide in scope and of necessity time consuming, but you may rest assured that this office fully appreciates your desires to have the remains of your son returned to Georgia for final interment and will do everything in its power to fulfill them at the earliest possible date.

In view of the fact that the Army Effects Bureau, Kansas City Quarter-master Depot, Kansas City, Missouri, has been designated to receive and ship the personal effects of deceased parsonnel over seas, a copy of your letter has been forwarded to that office for direct reply. This action has been taken in order to expedite reply and aliminate duplication of effort.

This office regrets, sincerely, the delay in answering your letter and wishes to extend its deepest sympathy in the loss of your son.

The official records of this office show that the remains of your son were interred in the U. S. Military Cametery, Margraten, Holland, Plot R, Row 7, Grave 156. This cametery is located approximately twelve miles northwest of Aachen, Germany and eight miles southeast of Maastricht, Holland.

There are no provisions whereby the War Department can furnish photographs of individual graves deceased military personnel or of military cometeries outside the United States, therefore, it is not possible to comply with your request.

Now that Japan has been defeated immediate plans are being formulated with a view to returning to the next of kin the remains of their loved ones. This secred duty will be carried out by the Government at its expense and insofar as practicable in accordance with the expressed wishes of the legal next of kin, who will be notified by this office well in advance of the actual return of the remains. The mission as a whole is world wide in scope and of necessity time consuming, but you may rest assured that this office fully appreciates your desires to have the remains of your son returned to Georgia for final interment and will do everything in its power to fulfill them at the earliest possible date.

In view of the fact that the Army Effects Bureau, Mansas City Quartermaster Depot, Kansas City, Missouri, has been designated to receive and ship the personal effects of deceased mirsonnel over seas, a copy of your latter has been forwarded to that office for direct reply. This action has been taken in order to expedite reply and eliminate duplication of effort.

This office regrets, sincerely, the delay in answering your letter and wishes to extend its deepest sympathy in the loss of your son-
